## MINUTES OF THE SPECIAL MEETING OF THE BOARD OF DIRECTORS

### Attendance

The special meeting of the Board of Directors of the Westglenn Metropolitan District was called and held as shown above in accordance with the statutes of the State of Colorado. The following Directors, having confirmed their qualifications to serve on the Board, were in attendance:

Also present were Elizabeth A. Dauer, Seter & Vander Wall, P.C.; Kay Hamel, District Accountant; and Richard Hamel, District Maintenance Supervisor.

### Call to Order

Director Sullivan convened the special meeting at 11:23 a.m., noting that a quorum of the Board was present and had confirmed their continuing qualification to serve as Directors.

### Disclosure Matters

The Board had been previously advised that pursuant to Colorado law, certain disclosures by the Board members might be required prior to taking official action at the meeting. The Board then reviewed the agenda for the meeting, following which each Board member confirmed the contents of written disclosures previously made, stating the fact and summary nature of any matters, as required under Colorado law, to permit official action to be taken at the meeting. The Directors specifically noted that they are members of a limited liability company that purchased additional ground located in the District on September 30, 1999, in an arms-length transaction. The Board determined that the participation of the members present was necessary to obtain a quorum or otherwise enable the Board to act.

Director Seeley reported he had disclosed his interest as an owner of property located within the District, and his association with Brookhill VII, LLC, developers in the District. This disclosure is associated with approval of items on the agenda

Director Sullivan had disclosed his interest as an owner of property located in the District, and his association with Sullivan Group Incorporated, and Brookhill VII, LLC, developers in the District. This disclosure is associated with approval of items on the agenda that may affect his interests.

## Approval of Minutes

Upon motion made, seconded and unanimously carried, the minutes of the March 15, 2019 regular meeting were approved as presented.

## Financial Matters / Payment of Claims

Ms. Hamel presented the District's financial reports for the period ending March 31, 2019. Director Sullivan inquired of Ms. Hamel who confirmed that all accounting continues to be maintained according to GAAP, there were no unusual transactions during the time period, there were no transactions involving the directors; and, the District remains capable of paying its obligations through 2019. Upon motion made by Director Sullivan, the financial report was accepted as presented.

## Attorney Report

Ms. Dauer reported that she sent a copy of the development fee resolution to the Builder's Square redevelopment representative, Susan Stanton.

Ms. Dauer reported on the recent passage of HB 19-1087, which permits the District to accomplish its statutory notice posting for meetings on a District website. She reported that she will continue to conduct research regarding the new law and District compliance.

## Park Update/ Maintenance Status Report

Mr. Hamel reported that they have finished aerating and fertilizing in the District and sprayed certain trees for ash borer and beetles.

Mr. Hamel presented the as-built drafted by Steve Linnenberger that will be submitted to the UNCC reporting system. The Board discussed the installation of signs warning against improper digging within the District.

## Other Business

The Board determined to reschedule its May meeting to Thursday, May 23, 2019.
