

**RESOLUTION

Park, Basketball Court, and Park Shelter Rules and Regulations

WHEREAS, the Westglenn Metropolitan District (the "District") is a special district located within Jefferson County, Colorado, organized pursuant to Article 1 of Title 32, Colorado Revised Statutes; and

WHEREAS, in accordance with the provisions of § 32-1-1001(1)(m), C.R.S., the District is authorized to impose rules and regulations, as amended from time to time, to govern the operations of the District; and

WHEREAS, the District has determined that it is in the best interests of the District and its residents to establish and adopt rules and regulations regarding the use of its public parks and recreation areas; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE WESTGLENN METROPOLITAN DISTRICT AS FOLLOWS:

1. The District hereby adopts the Park, Basketball Court, and Park Shelter Rules and Regulations attached as **Exhibit A**.
2. This Resolution is and shall constitute a legislative measure of the District, which may be modified only by formal resolution of the Board of Directors of the District.

Exhibit A

Park, Basketball Court, and Park Shelter Rules & Regulations

General Rules

1. Park users assume all responsibility of injury and liability to themselves and their children.
2. Children must be supervised at all times.
3. Park users and guests are responsible for the proper disposal of all litter and trash.
4. All pets must be on a leash and under the direct control of their owner at all times.
5. No animals shall be tethered to any District Facility or left unattended at any time.
6. Pet owners are responsible for the immediate removal of pet waste.
7. No alcohol, illegal drugs, firearms, weapons, open flames or fireworks are allowed.
8. Graffiti, vandalism, or destruction of park property is prohibited and subject to criminal and civil liability.
9. Fires/grilling is allowed only in self-contained grills provided at the gazebo.
10. Music of any type or source shall be kept to a level so as not to disturb other facility users or surrounding homeowners.
11. The District prohibits the following from District Parks, open space, landscape features and/or shelters:
 - a. Unauthorized motorized vehicles.
 - b. Practicing golf or having golf clubs in the park.
 - c. Littering or dumping of trash.
 - d. Horses.
 - e. Misuse/defacement of any park facilities, property or signage.
 - f. Fireworks (including model rockets) of any kind.
 - g. Tree houses, rope swings, fliers, signs or other attachments to trees or facilities.
 - h. Swimming, wading or boating in any detention pond or flooded area.
 - i. Glass containers of any kind.
 - j. Overnight camping and open fires.
 - k. Signs, banners, or other displays without prior written approval.
 - l. Disorderly conduct and/or abusive language.
12. Violations of these Rules and Regulations shall be prosecuted to the fullest extent as permitted by law.

Basketball Court Rules

1. The courts are available on a first come, first served basis.
2. The basketball courts are open from sunrise to sunset.
3. No reservation of the basketball courts is allowed.
4. Only non-marking athletic shoes are allowed on the courts.
5. No rollerblading, skateboarding, bicycling, scooter riding, or other non-basketball activities are allowed on the courts at any time
6. Use of profanity, obscenities or other inappropriate behavior is strictly forbidden.
7. Graffiti, vandalism, destruction of the courts, or removal of the basketball equipment is prohibited and subject to civil liability.
8. Glass bottles or containers are not allowed at any time.

Park Shelter Rules

1. Shelter use is on a first come/first served basis.
2. Park shelter users are personally liable for the destruction of District property and for any damage to nearby homes caused by activities in the Park/shelter.
3. All shelter users are responsible for removal and proper disposal of all trash, litter and debris and cleanup of spills in picnic areas.
4. No portion or area of a park or shelter shall be cordoned off or otherwise reserved for use without written permission of the District.
